ReviveOHIO continues as an ongoing monthly event as we join together with numerous Knox County churches for monthly outreach opportunities.

The need to transition to online worship for several months due to the virus meant discontinuing educational ministries Sunday mornings and Wednesday evenings.

With the start-up of Wednesday classes and Children's Church in August and September, we are back on track. However, challenges continue, especially those related to participation and leadership. Attendance (11-13) in the Wednesday adult Bible study group remains about the same as prior to the virus shut-down. The youth and young adult group functions with less than 5 participants. Hide n' Seek Club for elementary age children averages 2-3. Currently, 1-2 preschoolers are showing up on Wednesdays with parents of the children providing oversight. While Barbara Day keeps tabs on the nursery, there are no babies at this time needing this ministry.

#### PLEASE NOTE THE MINISTRY OPPORTUITY THIS SITUATION PRESENTS:

1. With adult volunteers to lead a simple session for preschoolers, the parents of these children could attend the adult Bible study. *This is a huge ministry invitation placed in our laps*! One of the families is unchurched, needs our love, support, a chance to get to know other adults and learn about the gospel.

2. Hide n' Seek Club has ample room for more children to enjoy memorizing Scripture and learning ways of applying to their lives. Again, this is huge!

- 3. Ditto for the youth/young adult group!
- 4. Ditto for the adult Bible study group!

As teachers and leaders ourselves, we are committed to the educational ministries of this congregation. We would love to see spiritual and numerical growth emerge in these arenas of teaching and learning for all age levels. We believe God desires the same. Let's embrace this current situation to make a difference!

Progress made on the upstairs children's and youth areas is so encouraging and beneficial. The attractiveness of these facilities adds incentive to invite others to join the classes happening in those spaces. Many, many thanks to the Trustees, Pastor Dan, Jill, and the super volunteers who put time and work into making this a reality.

## 2020 Annual Treasurer's Report

This year has seen many changes to our way of life and our way of worship. We have been forced to adapt and God has continued to be faithful in blessing our church. Though dealing with a global pandemic, your faithfulness in giving of tithes and offerings has provided more than we estimated coming into the year. We not only met our financial obligations for the year, but we were able to renovate our Christian Education building, and continued our investment in evangelism though the Warsaw Campground ministry.

Coming into 2020, we had an expected income through tithes and offering of \$120,000. As it stands today, we have received \$118,027 in donations to our General and Building Funds, and we are estimating that we will received upwards of \$123,500 by the end of the year. In addition, we were able to take advantage of the Paycheck Protection Program loan offered by the Small Business Association, which provided \$11,500 in funds needed to pay our employees during the time of shut down. This loan has been 100% forgiven as of the report date.

As of October 31,2020 our account balances are as follows:
